- a) Description of the Associate Professor Position, vacancy ref. 9. This position consists of:
 - Discipline: Civil Procedural Law Institutions I comprises: 1 lecture-hour for the Judicial Career Master's Degree Program – full time education;
 - Discipline: Civil Procedural Law Institutions II comprises: 1 lecture-hour for the Judicial Career Master's Degree Program – full time education;
 - Discipline: *Criminal Law Institutions* comprises: 1 lecture-hour and 3 seminar-hours for the Judicial Career Master's Degree Program full time education.
- b) the duties of the person applying for the vacant position are:
 - to give lectures;
 - to coordinate seminars and practical works;
 - to supervise bachelor theses and dissertations.
- c) minimum salary offered for the position when being hired: RON 3734+15% (doctoral bonus);
- d) the vacancy schedule:
 - the announcement regarding the organization of the competition shall be published two months at the latest before the date when the first stage of the competition takes place;
 - the period of applications for the competition starts on the day when the Official Gazette of Romania, Part III, publishes the vacant position and is over 15 days before the first stage of the competition takes place.
- e) the description of the examination procedure is provided in the appended methodology;
- f) the list of documents which applicants must include in their application file:
 - application form, signed by the applicant; this form must include a statutory declaration for the accuracy of the information included in the file – according to the appended model;
 - a proposal referring to the applicant's research an teaching prospects; the proposal must be written by the applicant (maximum 10 pages) and it represents one of the main examination criteria;
 - *curriculum vitae* printable format of the candidate and also in electronic format;
 - the list of works of the candidate in printed format and electronically;
 - the form according to which the applicant fulfils the university standards for taking part in the examination, as shown in the model form provided in the university's own methodology, which is to be filled in and signed by the applicant;

- the documents which confirm the PhD degree: legalized copy of the PhD diploma and, if the original PhD diploma is not recognized in Romania, the certificate which confirms its validity;
- the summary of the PhD thesis, in Romanian and in a language which is internationally spoken, in no more than one page for each language;
- a statutory declaration in which the applicant points out to the incompatibilities which might exist – as provided by Law no. 1/2011 – in case he/she passes the examination or the lack of such incompatibilities;
- statement regarding the basic teaching job quota;
- legalized copy of the ability certificate in case the applicant intends to obtain the position of a Professor;
- copies of other diplomas which certify the applicant's studies (baccalaureate diploma
 or certificate which confirms it, Bachelor's degree diploma and diploma supplement
 or certificates which confirm this degree, master's diploma and diploma supplement
 or certificate which confirms this degree, certificates which confirm attendance of
 professional training courses etc.);
- copy of the identity card or, if the applicant does not have an identity card, of the
 passport or another document which confirms his/her identity and which was issued
 as an equivalent of his/her identity card or passport;
- if the applicant has changed his name, he/she must present copies which confirm the change of his/her name – marriage certificate or the proof that the name was changed;
- maximum 10 research papers/studies (in an electronic format) written and selected (the most relevant for his/her professional accomplishments) by the applicant; if these papers are not available in an electronic format, they will be presented in a printed form;
- providing evidence for:
 - observance of the national standards for occupying didactical positions, which are specific for the didactical position of associate professor, in conformity with the minimum criteria approved by the Ministry of Education, Research, Youth and Sport for Panel 4, Legal Studies Area;
 - a course for a discipline included in the lecture/seminar hours that the applicant has to weekly give; the course has to be published after becoming a university lecturer, by a CNCSIS publishing house (with ISBN), or by a famous publishing house from abroad (with ISBN), as its main author or coauthor;
 - a compilation of texts and applications, a seminar guide published by a publishing house which is approved by CNCSIS (with ISBN), as its main author or co-author;
